# **Balance Sheet**

The District's combined Cash with Chase and LAIF balance was \$770,712 at month end. The District's total liabilities were approximately \$1.121 million at month end

### Profit and Loss

- Line 43 Generator Service Contract: YTD is over budget due to higher than expected maintenance costs for the Apache Generator.
- Line 62 Supplies & Equipment: YTD is at 80% due to bulk purchase of envelopes from Continental Utility Solutions.
- Line 63 Copier & Supplies: YTD is at 80% due to bulk purchase of billing statements from Continental Utility Solutions.
- Line 109 Main Street Improvements: YTD expenditures include invoices from Warren Duncan Contracting relating to demolition for the Main Street Project.
- Line 110 Meter Replacements & Other Capital: YTD purchases include (30) 5/8" meters & a \$3.3K invoice from Krieger & Stewart for work relating to the Super Map.
- Line 112 Vehicle Upgrades: YTD purchases include multiple invoices from WCLS for LED light installations on several vehicles.

As of October 31<sup>th</sup>, the fiscal year-to-date net loss is \$(35,871).
